The planning board last met on Tuesday June 20<sup>th.</sup> Review continued for Wash-N-Fold; Warner Tschoopp/137 &139 Jersey Avenue. A Self-storage Trailer Park which would include 20-foot shipping containers that would be 8.5x8.5x20 feet with a public parking lot.

The Board requested that the parking lot have one handicap space with striped lines they also requested a provision of no loitering. The Applicant said they will have 600 lumen lights, an enclosed dumpster and surveillance.

There was a continuation on the smoke shop located at 180 pike street the owners' provided copies of their licenses. The hours of operation would be 8am-11pm 7 days a week with 5 employees the plans had a revision date of 5/19/23. The location will need an exhaust with filtration.

A set of plans needs to be sent to the Orange County department of planning because it's on 209 they are required to be given 30 days to comment on the plans the board cannot decide until the 30 days. The Public hearing that was set is pending the moratorium which will be presented at the June 26<sup>th</sup> council meeting. They will be notified when it is safe to send out mailings and the application will go to all department heads.

An application for a pre submission for Dunkin' Donuts located at 291 East Main Street was presented the current site plan has a stacking issue of cars during busy peak hours the re design would turn the radius for the pickup side they would like to extend the rear parking lot just about 20 feet which will enhance the turning radius the drive through stack issue will be alleviated by 4 cars. Their goals are to amend the site plan to push the rear parking back it is not in a flood plain. The application for the public hearing was approved and will need a response from the county. Everything will remain the same with no conditions changed.
