Attached please find the Revenue and Expense as of March 31, 2022.

The chart below is a snapshot of the First Quarter 2022:

	2022 Budget	Q1 Actual	Remaining	% Used
Total Revenue	\$18,939,633	\$ 9,081,644	\$ 9,857,994	48%
Total Expense	\$18,442,626	\$ 4,927,489	\$ 13,515,137	27%

Overall revenue is running at 48% of budgeted levels and expenditures at 27% of budgeted levels. This indicates that we are maintaining our conservative position on spending through March 31, 2022. I will expect to see the expenses trend more upward through the year as we are already seeing the inflationary impact on gas and hard goods.

Please note that sales tax revenue was received in April and is not recognized until Quarter 2. Our first payment was for 996,000 which is 22% of budgeted revenue for that line.
