#### Regis Foster:

Okay. Thank you, Mayor. Our last meeting was last Thursday and some of the highlights that was discussed was overall activity. Crime is on the rise again, with increasing aggravated assaults, increasing arrests, and also fraud. The Chief discussed looking at purchasing body cameras, went through lengthy discussion on that. Chief updated us on possible retirements for this coming year. The chief updated us on the construction project in the police department, and also the chief discussed the mental health response pilot program.

#### Regis Foster:

The chief also discussed the ABLE program 2021. What this is, this is a police department has applied to Georgetown University of Law to participate in an active bystandership for law enforcement project, that's what ABLE stands for. This training is free of charge and provided through Georgetown's University innovative policing program in partnership with the law firm, Sheppard Mullin to provide an academic and research based training to officers to successfully intervene to prevent harm and to create a law enforcement culture that supports peer intervention with the goals of preventing misconduct, avoiding police mistakes, and promoting officer health and wellness. The agency is interested in participating in the training. It must commit to the program principles governing training, accountability, officer wellness, participation, pre-preliminary and post-implementation surveys. Following and assisting other agencies with the training, the department has submitted the initial application for the process and requested three members of the department be trained as train the trainers.

#### Regis Foster:

So, in order to proceed to the next step, the department will need to obtain four letters of support. Two letters must be from the community organizations, local groups advocating for changes in policing faith organizations, et cetera, vouching for the sincerity of the agency's interest and self-improvement in

general. Additionally, the agency must also submit a third letter from the lender of the agency and a fourth letter from the leader of the jurisdiction which the agency is based upon, and that would be the mayor. So, this program provides evidence-based training that fosters an organizational culture that embraces de-escalation, improved community interactions, and also improved wellness between the officers and the community. So, the chief is recommending at this time, and I'll make a motion to request the authorization from the council for the mayor to write a letter in support of the department to participate in this training initiative.

"trenchless" process rehabilitates in-ground wastewater lines. And whereas the City will contribute a total of \$26,500 of in-kind contributions in labor to remove the old sidewalks for the newly proposed 2020FY ADA East Main Sidewalk Project. #### Kristin Trovei:

Thank you. Finance met remotely on Wednesday, February 17th. Some items discussed include the status of the state fund withholding. There was talk at the beginning of the year that the state would release 15% of the 20% being withheld and keep 5% of the permanent cut, but since that comment or consideration was made there has been no word yet, or received since about anything regarding that. So right now, it's still the same as it was before.

#### Kristin Trovei:

We talked about the New York State retirement system. Their earnings are doing well at 10%, nearly 3% higher than expected. There was no mention of the state redoing the actuary work that was done on March 31<sup>st</sup>, 2020 during the height of the start of the pandemic which caused our rates to rise due to low market at the time. Our municipality and other municipalities across the state have been asking that

they re-evaluate that because when they did it, it affected us negatively and our rates went up. But the state has not considered our requests yet.

#### Kristin Trovei:

We discussed cash flow. It's low. The revenue anticipation note was closed with M&T. The clerk will be following up with the department heads on their 2021 capital note and serial bond requests, with the acknowledgment that capital note may not occur this year, and that a serial bond for things other than the tri-state bridge project overages might not occur. It depends on how things will affect the budget, and how the council decides to address those requests. Those requests are to be submitted to us about a week before the next finance meeting, so the council has adequate time to review and get any sort of additional information they made need.

#### Kristin Trovei:

We reviewed information on retiring debt schedule, as well any moneys that may be left over from past capital notes or serial bonds. If there is excess, either with the council not completing a project or a purchase, or a cost came in lower, the council and department heads need to decide what to do with those funds such as make the purchase, complete the project, reallocate for an appropriate purchase, pay off principle, et cetera, so that's something that the council will need to continue to look into.

#### Kristin Trovei:

We discussed the need for a new ozone generator, which we already approved. If you're coming to the city clerk's office, you don't have to make an appointment, but you do have to stand online. There are markers in the hallway where you will stand, one person in the office at a time.

#### Kelly Decker:

Okay, that and the other thing was, and Ms. Mann pointed on it a few times but I'm just going to reiterate, that the St. Patrick's Day parade is scheduled for March 7<sup>th</sup>. Again, if the numbers continue to stay the same or trend down, we will have the St. Patrick's Day parade with provisions. If for some reason we have to cancel, we are going to postpone it until April 11<sup>th</sup>. Now, so what are those things? We've extended that route almost three to four times. As she said, it's going to start on Orange... Well, line up is on Canal Street. And we're going to ask everybody that's in the parade that lines up to social distance. We have all of Canal Street to use.

#### Kelly Decker:

The roads will not be shut down, and the purpose of that is, if you want to come with your family to watch the parade, come and park your car along the parade route and sit in your car to watch the parade. This is the best for social distancing. The other thing that we're looking to do is the floats, and the bands, and the participants will be judged at the lineup. Towards the end of the parade route, they'll be handed their trophies, rather than there be a mass gathering.

### Kelly Decker:

Our bands will stop at several places along the way to perform their numbers, so there will be no gathering all the way down at the end at the promenade. And so, as the parade goes by the promenade, where I'm sure that there'll be people from the tourism board as well as the grand marshal handing out

the trophies, the parade will continue on and disperse from there. We're hoping that this is one of our first social events that will be safe, but that will also start to the realization that we can get back to some normalcy. So, thank you, and congratulations to Mr. McCarron on being named the grand marshal.

#### Kelly Decker:

That being said, I have some major news to give tonight. Many of the council members that were at the finance meeting are aware of this, as I brought it up at the finance meeting in executive session, but I have a retirement letter in front of me. It is by Mrs. Robin Waizenegger, our city clerk treasurer. She states that she has worked here for the past 16 plus years. It has been a memorable experience, filled with both it's highs and lows of managing city government. She had the pleasure of working with many different teams, both elected and hired officials, during her tenure which has broadened her perspective on government and its service to the public. She announces that her retirement from full time employment will be April 30<sup>th</sup>, 2021.

#### Kelly Decker:

So, at this time I am charging our finance committee, which is led by Kristin Trovei so she will lead this along with the finance committee to begin to process of seeking a new city clerk treasurer. And that would involve putting out a search for somebody for that position, as well as doing interviews. And so, Robin has also offered her services after her retirement VIA part-time VIA like a Zoom or online, as she will be out of the area for most of the summer. And I will bring that up again at finance, that piece.

#### Kelly Decker:

And so, with that said, 16 years working for the city. She's gone through a lot of struggles with us. I will tell you, for at least my last seven budgets it's been... I'm sorry, eight budgets. It's definitely been trying, but she has done a great job of making our city operate. We didn't always just agree. We agreed to disagree at times, and I'm sure other people have to. And we will have a time to properly bid her a fond farewell, but as of right now she has announced her retirement as of April 30th, 2021. So, we thank you Robin, even though she's not on here. She might be watching, she might not. And her deputy is on tonight, Bobbie Jo, and has been filling in for her for this week and doing a great job.
