Project 1:

Name: RR Crossing - Fowler and 4th St. - A) Pedestrian At-Grade Crossing, B) Overhead Pedestrian Bridge

Estimated Cost: A) \$250,000, B) \$2,500,000

Site Control: Norfolk Southern Railroad

Description:

A) Provide an at-grade crossing limited to pedestrians, extending from Fowler Street to Fourth Street. Currently there is no demarcation of a crossing location, with an unsafe and uncontrolled method of crossing the railroad tracks by individuals. The crossing will be limited to pedestrians with no further improvements for vehicles. The crossing will include all agency required warning devices, signaling, gates, fencing, channelizing, and safety features. Also, to be included is approximately 1500 feet of fencing to prevent crossing outside of the crossing area.

B) In lieu of the at-grade crossing a pedestrian bridge would span from an area approximately behind the Erie Depot to the area north=west of 4th street. Presuming there are obtained right of ways from Norfolk Southern Railroad, the bridge would span approximately 80 feet. The under clearance of the bridge would be approximately 23 feet, and the bridge would contain an elevator and stair tower on both ends. All ADA accommodations will be provided.

Considerations: Due to cost and ease of implementation, the possibility of an at-grade pedestrian crossing is preferred over the pedestrian overhead bridge. Both options require Norfolk Southern (NFS) approval. Initial conversations with NFS real estate were positive, but planning and decision making is centered with the NFS Crossings department and NYS DOT. Sustained communications are necessary to determine available options.

With the objective of bringing new businesses and housing units online in the downtown and lack of off-street parking, increasing ease of access between the historic downtown business district and the city's waterfront area with its current and future recreation, parking, and possible future development are critical to the advancement of each area currently separated by the Norfolk Southern railroad tracks that bisect the city north to south.

Project 2:

Name: Riverside Park Improvements - North - Parking, Public Art, Recreational Features

Estimated Cost: \$4,500,000

Site Control: City of Port Jervis

Description: 100 Car Parking - \$275k, "Welcome to Port Jervis" water tower (public art) - \$125k, Pavilion - \$1.5M, 7,000 SF all-inclusive playground - \$400k (Partner - Rotary Club of Port Jervis), relocate stage into amphitheater - \$350k, 6 pickleball courts - \$400k, basketball court - \$400k, new skatepark - \$600k, new 36-hole mini golf - \$300k, new fitness area - \$200k, relocate community gardens - \$30k

Considerations: Located on the banks of the Delaware River, and with the exception of the pump track and disc-golf course, Riverside Park has dated and underutilized features. With additional planning, the park would offer residents and visitors of all ages and abilities recreational opportunities.

This is a large, multi-featured project which would update the some 20 of the 40-acre Riverside Park. Though not officially a park, improvements made with grant funds will require the area to remain open to the public in perpetuity. After improvements are completed with grant funds, should the city decide to divest itself of the area, it must follow the alienation process. Rearranging and updating existing facilities would result in parking on city property and other various features. It is suggested that the features of this project be discussed and ranked. As the project is a large investment, a city match of some 50% is suggested, some of which would be in-kind. Other grant funds would be sought making this a phased project.

Project 3:

Name: Riverside Park Improvements - South - White Water Kayak Park (WWKP)/River Access

Estimated Cost: \$5,000,000

Site Control: City of Port Jervis.

Description: Establishment of an in-Delaware River kayak course and/or providing only river access at the southernmost portion of Riverside Park. Currently the only other recreational feature in this area is the new disc-golf course. The city's only other river access is via West End Beach.

Considerations: Originally conceived in the early 2000's, this project which per a 2012 preliminary economic impact assessment by the Orange County Planning Department, would potentially "bring in between \$10.9 and \$33.6 million in annual revenue to the area, and potentially may – directly or indirectly – support up to approximately 400 jobs" was attractive to many new Port Jervis businesses owners. Through uneven funding and increased requirements from the Army Corp of Engineers (ACOE), this inter-state project stalled due to the indication of the presence of the dwarf wedge mussel, a protected species and the resulting need for a mitigation plan. The Covid pandemic added to delays. With some \$56k left in a previous city bond, recently a small working group met to discuss the possibility of moving the project forward. Currently, the permit with the ACOE is closed. Reopening would require a review of the work to date, outreach to working partners, state and federal agencies and contracting with a firm eligible to perform a mitigation plan.

Unique to this project are the public access, educational opportunities and possibility of establishing additional mussel habitat.

Of concern is state and federal entity acceptance of work performed per request and productive movement to the next step.

Note: Tied to the WWKP is \$158k in city retained New York State Homes and Community Renewal program income dedicated to the purchase of lands under the city's Water Quality Improvement Program grant from the New York State Department of Environmental Conservation to expand the city's watershed.

Otherwise, alternately to take advantage of the city's location on the Delaware River and multiple members of the public's request for additional river access, is the consideration of adding another direct river access in this area. As this is a new concept, additional information is pending.

Project 4:

Name: Community Center - Ulster Place

Estimated Cost: \$8,500,000

Site Control: City of Port Jervis

Description: Construction of an approximately 13,000 square foot community center to include the renovation of the existing Farnum House. The Community center would include a full gymnasium with basketball court, a multipurpose room, offices, locker rooms, and toilet rooms. The project will also include the complete renovation of the Farnum House to house offices for the Recreation Department, a study room, a kitchen, and other miscellaneous office space. The renovated Farnum House and the new gymnasium building will be interconnected through common corridors. Site development will include additional parking and landscaping. Concept Plans are available. If selected, the current DRI boundary is open to adjustment.

Considerations: The current city Youth and Community Center at 134 Pike St. was originally built in 1909 for the B.P.O.E. of Elks. Aged, the building offers a Rec room on the ground floor, basement bowling alley, meeting rooms and offices on the second accessible by a lift or stairs, and offices and previous ballroom with no heat, AC or windows used for sports training and juvenile detective offices on the third. In spite of the recreation department's best efforts, the building is limited. Constant to every survey, the youth of Port Jervis say there is little for them to do. With new facilities, new activities would engage youth and others making this an intergenerational facility. As this is an expensive project, a city match is highly suggested. Additional funding will be sought.

Project 5:

Name: Complete Streets/Greenway/Smart Growth - A) Jersey Ave. Sidewalks, B) From Metro North - Sidewalk to Erie Turntable, Pave Muni-Lot at Front and MacArthur Circle and NFS ROW behind Front St. Buildings

Estimated Cost: A) \$750,000, B) TBD

Site Control: City of Port Jervis/Norfolk Southern Railroad (NFS)

Description: A) Replacement of approximately 4,000 linear feet of 5-foot-wide concrete sidewalks. The sidewalks will be removed and replaced on both sides of Jersey Ave., from Fowler Street to East Main Street. The sidewalks will be completed under the Complete Streets model with accommodations for trees, lighting, ADA accessibility, etc. Plans are needed. City site control. B) Sidewalk from Metro North to Erie Turntable (NFS)//Repave municipal lot at Front and MacArthur Circle (City site control), pave ROW behind Front St. buildings (NFS site control).

Considerations:

A.1) Originally zoned service commercial, Jersey Ave. received a Central Business District (CBD) in the 2020 zoning update. In addition to the current CBD, Jersey Ave. offers a wide mix of businesses which provide a variety of goods, services and employment options. With few buildings left in the Front St. downtown, this area of Jersey Ave. offers room for business and residential change which is beginning as businesses are being sold. New sidewalks would carry the changes that have been established in the current downtown and would integrate Complete Street, Greenway Compact and Climate Smart concepts into the city's most highly distressed area. New sidewalks would be accompanied by properly sized tree pits and plantings, ADA features, and lighting.

B.2) Metro North's First-Mile- Last-Mile program supports multi-modal access to and from its commuter stations. Without Norfolk Southern (NFS) approvals, the city would repave the corner lot near the AV Outlet and make space for scooter and electric bike rentals. Otherwise, with necessary NFS to assist with traffic control, street directional changes including a one-way on the last block of Sussex St. and around to the same city lot would provide additional access to an area difficult to navigate. Additionally, safe walking access to the Erie Turntable area from the train station is desired and would be achieved by the installation of a sidewalk from the train station, along the tree line behind Walgreens, directly to the turntable.

Project 6:

Name: Public Restroom at Ball St. Municipal Lot

Estimated Cost: \$350,000

Site Control: City

Description: This project would result in the construction of a new stand-alone masonry building providing both men's and women's separate toilet facilities. Both rooms will consist of two toilet fixtures, plus an ADA compliant stall, and required sinks. Sidewalks providing an accessible route will also be provided, as well as a family room. Port Jervis DPW would provide an in-kind contribution.

Considerations: With the exception of restrooms in the municipal building, there are no public downtown restroom facilities. The restrooms in Riverside Park are closed unless there is a public event and are not accessible to the downtown. Currently, visitors frequent local businesses to use their facilities.

Project 7:

Name: Placemaking

Estimated Cost: \$500,000

Site Control: City

Description: This project would support walking tour apps, marquee signage at gateways, wayfinding throughout, benches, plantings, public art installations. Vertical digital display for announcements, maps, merchant advertising (Tri-Sate Chamber of Commerce partner) is proposed for the downtown Promenade.

Considerations: With recent directional signage installed, easy navigation, publication of local business, recreational, cultural, and historic features continue to be limited. Visitors are left to wonder what Port Jervis has to offer, and it is as been proven time and again that even local residents are not aware of the variety of local features.

Project 8:

Name: City Marketing Campaign

Estimated Cost: \$125,000

Site Control: City

Description: Funds would pay for acquisition of a contractor which would research options suitable to the city and recommend goals, objectives and methods. Implementation would be incorporated into city website, tourism and economic development outreach.

Considerations: To support placemaking activities and the ongoing investments made by NYS, the city, business owners, not-for-profits and others in Port Jervis, a cohesive city branding/marketing campaign would encourage long-term, unique local, state, regional and international branding.

Project 9:

Name: Small Projects Fund

Estimated Cost: \$600,000

Site Control: City

Description: Those private projects that are not large enough to merit stand-alone DRI status would be considered for grouping under the Small Projects Fund, the maximum of which will be \$600k total. The projects will be focused on second and third floor activation (office/residential), façade improvements and weatherization.

Considerations: The city will be responsible for administration, which includes the need to hire a contractor who would track each component project for timeliness and completeness. Ten-percent (10%), of the awarded fund will be allocated to administration and the contractor. Additional funds may be necessary.

Project 10:

Name: Two Erie Turntable Area Projects (Formerly Transportation History Center (THC)

Estimated Cost: \$1,000,000+

Site Control: City

Description: Continued collection and formalization of city historical transportation-based projects at the Erie Turntable. Entities include two not-for-profits, the Erie Turntable Inc. and the Tri-State Railway Preservation Society (TSRPS). The Erie Turntable project is anticipated to be a five-phase, approximately \$13.5M project. Phase 1 includes utility installation, perimeter fencing, track installation and repair, complete tracks into six roundhouse stalls, soft costs and contingencies. With the additions of a raised ADA entrance into a second box car and installation of HVAC mini-split for heat and AC, solar panels for power, and educational kiosks, bolded items include TSRPS objectives. The Erie Turntable, Inc., includes the Conrail Historical Society and Operation Toy Train, under which is the Dining Car Society.

Considerations: In June 2023, the original DRI entity included in the city application, the Transportation History Center, ceased operations. As the site control of the 8+-acre site is contracted to the Outdoor Club of Port Jervis by the city, additional input by the city is needed.
