ADVERTISEMENT FOR BIDS

Equipment For Sewer and Stormwater Infrastructure Rehabilitation Program.

Sealed proposals will be received by the City of Port Jervis, New York (hereinafter called the “City” or “City of Port Jervis”), until **12:00 PM on July 29, 2026**, for the furnishing of one (1) Cured-In-Place Pipe (CIPP) continuous air inversion machine and associated accessories for use in the City’s sewer and stormwater infrastructure rehabilitation program at which time, all bids will be publicly opened and read at the City of Port Jervis City Hall, 20 Hammond Street, Port Jervis, New York.

The city seeks proposals for equipment that will support in-house or contractor-assisted CIPP liner installation for gravity sewer mains ranging from 6 inches to 12 inches in diameter. Proposals should demonstrate that the equipment offered is suitable for sustained field operations under a variety of conditions commonly encountered by municipalities in New York State, including confined easements, off-pavement access, and variable weather conditions.

Copies of the bid package and plans are available digitally or as paper copies, paper copies which may be obtained at the Office of the City Clerk-Treasurer at the above address during normal business hours starting on **July 15, 2026**.

Each bid shall be submitted in accordance with the Instruction to Bidders

Bids shall be enclosed in a sealed opaque envelope bearing the name and address of the bidder, addressed to the City of Port Jervis, 20 Hammond Street, Port Jervis, NY 12771, and endorsed "RFP – Purchase of Cured-In-Place Pipe (CIPP) Inversion Machine"

All bids must meet the requirements of the General Municipal Law of the State of New York and all other applicable statutes. All documents submitted in connection with this bid will become the property of the City of Port Jervis and the City will not return bids or bid documents.
