Public Comment - None**Mayor Decker - Police -****February Highlights:**

- IBR Reporting: In 2022, we converted to the National Incident Based Reporting System from the traditional Uniform Crime Reports. The IBR Reporting system is a thorough reporting mechanism that captures the true nature of crimes reported in a community as opposed to the UCR which only allows for the reporting of one offense per incident.
- IBR Offenses: Total reported offenses for the month of February 2023 as compared to February 2022 have increased by 5.8%. IBR offenses have further increased by 4.6% year to date as compared to last year.
- We continue to tracking Part I Crimes (Burglary, Robbery, Larceny, Murder, Rape, Aggravated Assault, Motor Vehicle Theft) to provide historical comparisons.
- UCR Part I Crimes to date in comparison to 2022 have decreased by 35%. The variation in crime data from the UCR and IBR statistically demonstrate the basic weakness of the UCR crime reports due to the hierarchy rule and limited reporting requirements.

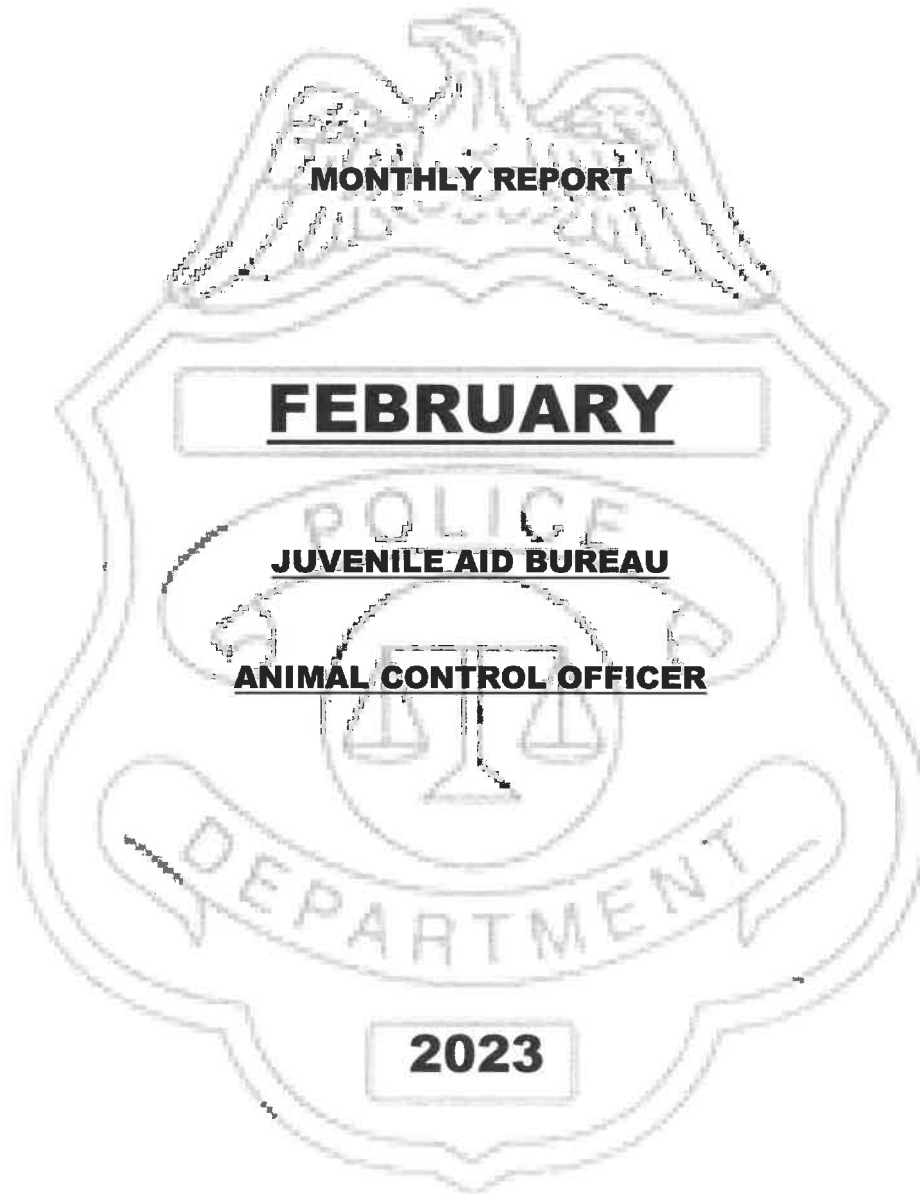
