## Recreation Commission Wednesday, November 8, 2023 6:15pm

A meeting of the Port Jervis Recreation Department was held Wednesday, November 8, 2023 at 6:15pm. The meeting was called to order at 6:19pm. The following were in attendance:

#### **Public Comment:**

Jason Vicchiariello, first ward resident, was present to express his concerns that other residents had reached out to him to ask why the parking lot at West End Beach was closed. He is concerned that taxpayers don't have access to the beach to fish, kayak, or to have a place to sit for lunch. He is also upset that the land that his family donated is not being used for what his family intended it to be used for. The Director of Recreation and the Commission responded to his concerns by explaining that the barricades to the park are a temporary solution until the permanent gates are installed. Barricades are there to try and prevent more vandalism to the brand new almost \$100,000 parking lot. The timeline for the gates installation is scheduled for this fall. The gates would be similar to the gates that are used at Elks Brox Park and the fire companies would all have access to the gates. Parking is still available at the bathhouse for anyone wanting to access the river for fishing or kayaking. The Commission, as a governing board, recommended that the barricades remain until the permanent gates are installed. John will include signage to indicate that the barriers were temporary.

Recreation Budget hearing is scheduled for 11/15 at 6:45. Two big items to be discussed are the budget for Church St. repairs and a key fob system for the Dog Yard. John is going to offer a walking tour to any current and newly elected officials to see the conditions at Church St.

Janessa Jenkins has been appointed as a long term replacement/sub Recreation Leader. She will be covering leaves and vacations for the other employees.

14 people have signed up for the January 6<sup>th</sup> Devil's game. John will advertise the game.

John would like to have food trucks at the conclusion of the 5K race. He would like to create an atmosphere that people will want to go to at the end of the race. He will follow up at next month's meeting to get the commission's thoughts or ideas.

John will get in touch with Tim Simmons to discuss the annual Polar Plunge.
