Fire Chief's Report:

Old Business:

- AFG Grant has nothing to report
- The Station Design Meeting is still set for May 19th
- Apparatus replacement is waiting on guidance. There was no finance meeting last month but there is one this week
- Station RFQ has had some progress. A week ago there was a meeting with Will and Valerie.
- The training center will get a new camera with 4 views and maybe installed where the old pumps used to be.
- Lexipol is doing well and moving forward.
- Rescue 3 went to Texas.
- C-1 is still on the wait list for being built.

New Business:

- March Run sheets and Quarterly Run sheets are included
- Pump testing was all done with minor issues

- Fit testing is in progress.
- Engine 5 is OOS again and maybe a Turbo issue.
- Hose and Ladder testing is all done. Ladders are all good. Lots of hoses OOS and getting new hoses has a 10 month waiting period.
- Live fire is done.
- New SCBA compressor is being ordered
- TC energy grant was awarded for a 2nd dryer.
- There was a discussion regarding the Hydrant Flushing and the Flow testing.
- The light in the officers closet at the Fire Police needs to be replaced.
- It was \$300 to repair the garage door at Engine 5s.

Emergency Management/ Vehicle Maintenance Report:

Old Business:

- Still waiting on KME for Truck 7 repairs
- E-5 OOS and it could be an issue with the Turbo.
- E 4 primer needed to be rebuilt
- E 6 fixed
- T 7 had an issue with the knuckle for the nozzle. A loaner was installed until the other one is fixed.
- There was a discussion about the new phone lines not having an analog line.

New Business:

- There was a drill Lake Wallenpaupack.
- There is a meeting at Eagle Crest on May 6th
- The NYC reservoirs are at 91%, 92%, 94%. If they were not at 100% by May 1st the DEC can lower the flow to the Delaware River. This will make the river low for the rescue boats.
- The Feeder Lines should be a priority on being fixed as well as the spill way.
- There is nothing this year about the Cannonville Project

Fire Inspector

- In 2024 we were 273 inspections behind. 2025 we are only 109 behind.
- 100 Pike is working on upgrading their system
- Working on a radio communication system for the hospital and for the new hotel, when it opens.
- Silk Mill Condos upgraded its Panel and Pull Stations
- 75-85 Pike Street installed a new Knox Box on the Ball St side and updated the identifications of the units.
- 30 Canal St will get a new Knox Box
- I have been sharing contact information with the police as soon as I get it.
- KFC installed a height bar which would make it difficult for any tall apparatus to go around the building An Apparatus was going to go there this week to check it out.





-140 Hammond St. Cornerstone Family Healthcare. I am working with the manager and the alarm company to have the panel read the correct locations of the devices.

-290 East Main St, KFC, apparatus access issues. The owner is removing the temporary storage containers, and we are going to run a test to see if the height marker needs to be removed.

-30 Canal St, Knox Box needed. The director at the hospital is ordering and installing a Knox Box.
