Police Committee Meeting Minutes: 27 October 2022 6:15 pm

Meeting called to order by Mr. Foster with the following members in attendance: Ms. Miller, Ms. Mann, Mr. Siegel, Mr. Decker, Mr. Livingston, Mr. Simmons, Ms. Newhauser, Chief Worden.

<u>Public Comment:</u> No public comment received.

New Business: Updates-

Third Quarter - September Crime Report - Chief Worden reviewed key statistics for the 3rd Quarter of 2022 including Part I and Part II Offenses and accident data. Part I overall crimes have increased by 40.3% as compared to 2021 while Part II offenses have decreased by 8.9%. Key increases in Part I offenses includes the crimes of aggravated assault, burglary, larceny and robbery while decreases have been experienced with offenses involving Rape and motor vehicle theft. Part II notable increases have occurred in offenses related to driving while impaired, simple assault and weapons related offenses while decreased have been observed in cases involving controlled substances, and fraud. Overall, arrests have increased by 40.7% while reported incidents or calls for service have relatively remained consistent with 2021. Accidents involving property damage have increased by 10% while accidents involving personal injury have decreased by 57.8%.

<u>Review of accidents: Orange Street/Canal Street</u> - A crash study was conducted for the intersection of Orange and Canal Street based upon a request to implement a 4-way stop intersection at this location.

Between the time of October 3rd, 2017, through October 3rd, 2022, there have been 575 reportable accidents that occurred at all intersections within the City of Port Jervis. 7 accidents of the 575 accidents occurred at the intersection of Orange St. at Canal St. The following is a brief description of the accidents that occurred at this location:

- 11/11/2017 Fail to yield right of way.
- 06/08/2018 Fail to yield right of way.
- 10/11/2018 Fail to yield right of way.
- 03/05/2020 Following too closely, rear ended vehicle slowing for pedestrian crossing.
- 08/24/2021 Fail to yield right of way.
- 01/08/2022 View obstructed by large snowbank.
- 09/29/2022 Fail to yield right of way.

Based upon the data review, the committee decided that the four-way stop intersection was not warranted at this time.

<u>Grace Church Trunk or Treat</u> – The department will be participating in the upcoming trunk or treat at Riverside Park on October 29.

<u>Halloween Safety Initatives</u> - Officers have been visisting area pre-schools and ASK Elementary School providing Halloween Safety and distributing high visibility-refelctive halloween bags with activities to children. In addition, officers will be distributing glow sticks to children on Halloween and fire department crews will be deployed in all city wards to increase safety.

Training Report: The department is providing training to member(s) in the following areas-

- General In-Service scheduled for wellness, ABLE (Active Bystandership), Investigation skills updates.
- Cellular Telephone Evidence and Data
- Crime Scene Processing
- School Officer Basic Training-Orientation
- Firearms Training

No Shave Fundraiser: The department will be participating in the No Shave annual fundraiser with donations being designated to support local charitable organizations and families. Male officers are permitted to grow facial hair while female officers have elected to allow their hair to be worn in a pony tail for this charitble event.

<u>Police Exam Recruitment</u>: The department is planning to launch a police officer candidate recruitment effort for the anticipated civil service exam scheduled for September 2023.

Youth Drug/Violence Prevention Program: The department developed a revised seven week drug, alcohol and violence prevention program with the Port Jervis Middle School to replace the Too Good For Drugs Program. 8th grade health students will receive 7 lessons provided by a certified instructor from the department partnered with health teacher Rick Graham throughout the school year.

<u>Christmas Parade Route</u> – The committee reviewed a proposed change to the annual Christmas Parade Route (Start at Airport Park, Proceed to Pennsylvania Avenue in Matamoras to Pike Street, Port Jervis, to East Main Street, to Fowler Street, to Jersey Avenue, to Front Street, to Sussex Street to Ball Street). The parade route will be difficult to staff due to the multitude of intersections and comments were received about the extended length of the parade during the evening hours. Chief to discuss committee concerns with parade committee from the Chamber of Commerce.

OC Drug Task Force- A review of the recent multi-agency narcotics investigation was conducted with a request from the Chief of Police to review expanding their part time participation with the task force to a full time commitment based upon the success of recent high level investigations. Committee members were provided with an informational memo containing key arrests and seizures since the department increased their partnership with the Orange County Drug Task Force. Committee to continue to review.

<u>Drill Prep- Bon Secours Community Hospital</u>- The department is working with the Orange County Sheriff's Office to host a multi-agency drill on December 10th at Bon Secours Community Hospital involving police, fire, ems and other emergency services agencies.

<u>Grant Award- DCJS Anti-Violence Initiative</u> – National Night Out - \$6,250.00- Chief Worden reported the department received this grant through Sen. Skoufis to off-set the costs of providing the annual National Night Out Against Crime outreach in 2022.

Old Business: Updates

Range Building Bid - Engineer John Fuller is finalizing the revised floor plan and bid documents to present to the Council.

Body Cameras - The department is awaiting the final installation of software and will deploy training during the months of November and December.

Committee Comments:

Committee members discussed the following concerns regarding parking conditions on Front Street:

- Limited visibility of pedestrians standing in crosswalks due to parking spaces located directly adjacent to crosswalk
- Vehicles parking on the end of Sussex Street and behind the store fronts on the Front Street access road making it difficult for vehicles and emergency vehicles to access the service road.
- Lack of handicapped signage at designated spaces.
- Chief to coordinate with DPW to conduct a site review and make recommendations to the committee during the December meeting.

Mr. Siegel reported on an illegal dumping condition on Pike Street involving a privately owned dumpster. Mr. Siegel advised that persons without authority are depositing trash at the site and it is is accumulating outside the dumpster on the parking lot. Mr. Siegel will advise the owner of the property to contact the police department to report the matter.





Clerk-Treasurer Laura Quick asked the Committee to review/update in the City of Port Jervis Employee Handbook, Section 202: Part-time hours. It reads a max. of 988 hours per year which would be 19 hours per week. She researched the Affordable Care Act and the NY State Retirement System, both indicating the max. as 1,534 hours per year, which equates to 29.5 hours per week. The other item with old information is Section 605: FMLA pertaining to service members and some others. She recommended that the City attorney look at it and make the necessary changes.

Also Mr. Brady's Fire Inspection fees are currently billed to a business owner as per our code. If they choose not to pay, we have to take them to court to recoup. If we change this to bill the building owner, we are then in the position to relevy unpaid invoices.

Discussion on considering waiving dog license fees for veterans and first responders. Where first responders are concerned, a clear definition of a first responder must be addressed and what documentation the Clerk's office must collect as proof. Because Port Jervis dog licensing options are 1 year and 3 year, it is probably wise to offer the 1 year licensing and not the 3 year as a first responder could potentially not commit to a period of 3 years of being a first responder. Also, the City must turn over a portion of the licensing fee to the State of New York. It should be researched what this means if the City enacts this proposal in terms of cost that the City may have to absorb, whether to waive the entire fee or just the City portion but not the State portion.

Old Business:

WHEREAS, under the terms of the WIIA Grant Program the \$4,562,500 Grant is to be used by the City to reduce the City's NYSEFC \$20 Million Loan Commitment by up to twenty-five percent (25%) of the \$20 Million CWSRF Sewer Main & Relining Project; and

WHEREAS, through the use of the WIIA Grant, the City shall borrow nearly \$5M less under the EFC Loan Commitment; and

WHEREAS, City Representatives currently are consulting with EFC Representatives to work out the final terms of the WIIA Grant and the EFC Loan commitments, but the award of the WIIA Grant should make it possible for the City of Port Jervis to carry repayment of an approximately \$15M EFC loan over either a 30 year or a 40 year repayment plan, the exact term of repayment is yet to be determined.
