**INDEMNITY AND HOLD HARMLESS AGREEMENT**  
**FOR USE OF THE DOG PARK OF THE CITY OF PORT JERVIS**

1. The USER agrees to fully indemnify, save and hold harmless the City of Port Jervis, its heirs, executors, agents, officers, directors, servants, employees and assigns from and against any and all liability of any type whatsoever, including but not limited to, any and all damages, expenses, causes of action, lawsuits, claims, penalties, fines, assessments or judgments relating to, arising out of or occurring in connection with USER'S use of Dog Park of the City of Port Jervis.
2. The USER shall, at their own cost and expense, defend any and all actions or suits which may be brought against the City of Port Jervis, its heirs, executors, agents, officers, directors, servants, employees and assigns or in which the City of Port Jervis, its heirs, executors, agents, officers, directors, servants, employees and assigns may be impleaded or included with others upon any such above mentioned claim. In the event of the USER's failure to do so, the City of Port Jervis, at its option without being obliged to do so, may, at the USER's cost and expense and upon prior written notice to the USER, defend any and all such suits or actions. The USER shall satisfy, pay and discharge any and all judgments that may be obtained or recovered against the City of Port Jervis, or any of its heirs, executors, agents, officers, directors, servants, employees and assigns or in which the City of Port Jervis, or any of heirs, executors, agents, officers, directors, servants, employees and assigns may be impleaded with others. The USER shall pay the reasonable cost of any such defense including, but not limited to attorney's fees of the City of Port Jervis.
