**RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF PORT JERVIS**

SUBMITTAL: DEPARTMENT OF HOMELAND SECURITY FY 2023 ASSISTANCE to FIREFIGHTERS GRANT (AFG)

WHEREAS, the City of Port Jervis' Fire Department volunteers' Self-Contained Breathing Apparatus (SCBA) personal protection equipment is reaching its end-of-useful life; and

WHEREAS, the replacement of the equipment is expected to cost an estimated minimum of \$578,900; and

WHEREAS, the Assistance to Firefighter Grant Program, funding number Opportunity Number: DHS-23-GPD-044-00-98 opened on January 29, 2024 at 8:00AM ET and closes March 4, 2024 at 5 p.m. EST; and

WHEREAS, the City of Port Jervis is an eligible applicant with the understanding that a FEMA calculated minimum 5% project total cash match equaling an estimated \$27,567, plus any difference between the award and actual cost of the SCBAs is required; and

WHEREAS, the performance period is two-years from the date of award, with possible extension, NOW THEREFORE, be it resolved that the Common Council of the City of Port Jervis, hereby approves the submission of said grant application no later than March 4, 2024, at 5 p.m. EST and that the Mayor, or his designee Valerie Maginsky, executive director of the Port Jervis Community Development Agency is authorized to execute any and all documents in connection with the application.
